KIRISH (falsafa doktori (PhD) dissertatsiyasi annotatsiyasi)

Tadqiqot mavzusining dolzarbligi va zarurati. Keyingi yillarda fanlararo integratsiyaning kuchayishi fan tarmoqlarida o‘zaro ta’sir, muammo va masalalar yechimida hamkorlik yuzaga kelishiga sabab bo‘ldi. Ilm-fan taraqqiyoti natijasida boshqa sohalar qatori tilshunoslikka ham yangicha nuqtayi nazardan qarala boshlandi. Jahon tilshunosligida tilning amaliy funksiyasidan samarali foydalanish va turli sohalar, shu jumladan, yurisprudensiyaga tatbiq etish masalasida turli tadqiqotlar yaratilgan. Xususan, Rossiyada konfliktli matnlarni lingvistik ekspertizadan o‘tkazish bo‘yicha davlat va nodavlat ekspertiza markazlari tashkil etilgan bo‘lib, yozma va og‘zaki matnlar, audioyozuvlар lingvistik ekspertiza qilinadi. Shuningdek, haqorat mazmunli birliklarni lingvistik ekspertizadan o‘tkazish uchun haqorat va so‘kinish bilan bog‘liq leksik birliklar bosma va elektron lug‘at ko‘rinishida tizimlashtirilgan.¹

Dunyo tilshunosligida lingvistik ekspertiza kriminalistik holatlarda matnni tahlil etish va dalillarni aniqlashdagi yetakchi omillardan biri bo‘lib ulgurgan. Xususan, Jon Olsson kriminalistika bilan bog‘liq 50 ga yaqin vaziyatlarda lingvistik ekspertiza orqali masalaga yechim topish mumkinligini asoslaydi.² Bundan tashqari, Manchester va Aston universitetlarida maxsus lingvist-ekspertlar tayyorlash bo‘yicha tizimli ishlar tashkil etilgan bo‘lib, xorijlik tadqiqotchilar ham masofaviy tarzda o‘quv kursida tahsil olishlari mumkin.

Biroq o‘zbek yozma matnlari til va etnik, psixologik xususiyatlariga ko‘ra boshqa tildagi matnlardan tubdan farq qiladi. O‘zbek tilshunosligida til va yurisprudensiyaning bog‘liqligi masalasi sud nutqi va terminologiyasi, shuningdek, qonun hujjatlari tili bilan bog‘liq tadqiqotlar misolida ochib berilgan.

Tadqiqotning dolzarbligi shundaki, sud-ekspertiza tizmida yozma matnlarda turli darajadagi holatlar (haqorat, so‘kish, obro‘yiga putur yetkazish, plagiatlilik, anonimlik, korrupsiya)ni baholash va tahlil qilish ehtiyoji kuchayib bormoqda. Bu esa bevosita lingvistik ekspertizani belgilashga zarurat borligini bildiradi. Zamonaviy tilshunoslik rivoji natijasida turli nazariyalar ilgari suriladi va asoslanadi. Fikrimizcha, mavjud nazariy g‘oyalarni amaliyatga tatbiq etish va uning samaradorligini belgilab olish zarur. Ushbu ko‘rsatilgan jihatlar aynan lingvistik ekspertologiya uchungina emas, balki zamonaviy tilshunoslikning boshqa sohalariga ham muayyan darajada taalluqli. Respublikamizda sud-huquq tizimini takomillashtirish, kriminalistika bilan bog‘liq matnlarning mohiyatini yoritish, anonimlik holatlarini izchil asoslash, turli jinoyatlarning oldini olishda lingvistik ekspertizaning o‘rni yuqori. Shu ma’noda, respublikamizda sud-lingvistik ekspertizalarini tashkil etish, baholash, intellektual mulkka tajovuzning oldini olish, shuningdek, lingvist-ekspertlar tayyorlash, maxsus markazlar faoliyatini tashkil etish zaruratining kuchayib borayotganligi tadqiqotning dolzarbligini belgilaydi.

Tadqiqotning respublika fan va texnologiyalari rivojlanishining ustuvor yo‘nalishlariga mosligi. Tadqiqot ishi respublika fan va texnologiyalari

rivojlanishining I. “Axborotlashgan jamiyat va demokratik davlatni ijtimoiy, huquqiy, iqtisodiy, madaniy, ma’naviy-ma’rifiy rivojlantirishda innovatsion g‘oyalar tizimini shakllantirish va ularni amalga oshirish yo‘llari” ustuvor yo‘nalishiga muvofiq bajarilgan.

Muammoning o‘rganilganlik darajasi. Lingvistik ekspertizaning aynan qachon yuzaga kelganligi masalasini aniq dalillar bilan asoslash qiyin. Ilm-fanga kirib keluvchi har qanday istilohning o‘z tarixi, shakllanish bosqichi va taraqqiyot davri bo‘ladi. Lingvistik ekspertizani ham aniq bir davrda vujudga kelgan va shakllanib ulgurgan deb ayta olmaymiz. Nutqda ishlatiluvchi so‘z va gaplarning turli atributlari, xususan, uzunlik, tembr kabilarni umumlashtirish nutq muallifining ruhiy-psixologik holatiga tashxis qo‘yish imkoniyatini yuzaga keltiradi. XIX asrda matematik olimlar nutq atributlarini umumlashtirish kerakligini ta’kidlaydilar. Aniqroq aytganda, ular so‘z uzunligi, gap uzunligini o‘lchash va gapning qurilish shaklini tekshirish lozimligini ta’kidlashadi. Sanoat, iqtisod, ijtimoiy-siyosiy aloqalarning yangicha ko‘rinishda paydo bo‘lishi fanlararo tadqiqotlarning o‘ziga xos muammolari bilan shug‘ullanishni rag‘batlantirdi. Ushbu muammolar, qoida tariqasida, kasbiy yuridik faoliyatning turli ko‘rinishlarida (qonun ijodkorligi, huquqni muhofaza qilish, sud notiqligi, sud ekspertizasi) filologik ta’minoti bilan bog‘liq ravishda yuzaga keldi. Xususan, lingvistika va yurisprudensianing bog‘liqligi masalasida rus tilshunosligida Y.L.Ziyangirova, Y.A.Grishenkova tomonidan tadqiqotlar yaratildi.³ Ekstremizm bilan bog‘liq matnlar lingvistik ekspertizasi M.V.Ablin tadqiqotida o‘z aksini topdi⁴. Lingvistik ekspertizaning shakllanishi va amaliyotga tatbiqini A.N.Baranov⁵, Y.A.Belchikov, M.V.Gorbanevskiy, I.V.Jarkov⁶, Y.N.Bondarenko⁷, K.I.Brinev⁸ o‘z ishlarida tavsifladi. Haqorat bilan bog‘liq holatlarda lingvistik ekspertizalar tasnifi N.D.Golev⁹, Y.I.Galyashina¹⁰ tomonidan amalga oshirildi.

Jahonda ijtimoiy tarmoq xabarlari va anonim xatlarni lingvistik ekspertiza qilish tamoyillari M.Kultxard¹¹, Tim Grant¹², Nicola-Jan Smit¹³ tomonidan ishlab chiqildi. Kriminalistik vaziyatlarda lingvistik ekspertizani tashkil etish masalalari Andrea Nini, Jon Olsson tadqiqotlarida yoritildi.¹⁴

O‘zbek tilshunosligida tilning turli sohalardagi tatbiqi, voqelanishining bevosita sud bilan bog‘liqligi xususida Sh.Iskandarova¹⁵, S.Hasanov¹⁶, Sh.Shahobiddinova¹⁷, X.Hayitov tomonidan tadqiqotlar yaratildi¹⁸. Yurisprudensiya va lingvistika fanlari munosabati, terminologiyasi bo‘yicha R.Sharopova¹⁹, O.Tursunova²⁰, G.G‘ulomova²¹, Sh.Ko‘chimov²², M.Qosimova²³, L.Karimova²⁴ ilmiy tadqiqot ishlarini olib borishgan. Sud nutqi va leksikasi masalasi Q.Mo‘ydinov²⁵, A.Saidov²⁶ ishlarida asoslab berildi. Yuridik hujjatlarni lingvistik bilimlar asosida tahlil qilish xususida K.N.Qayumova²⁷ tadqiqot ishlarini olib bordi.

Ushbu tadqiqotlar til va huquqning bog‘liqligidagi muayyan muammoli masalalarni yechishda dolzARB ahamiyat kasb etadi. Biroq o‘zbek yozma matnlarini turli vaziyatlarda, xususan, shaxsni obro‘sizlantiruvchi birliklar, matn avtorizatsiyasi bilan bog‘liq holatlarda lingvistik ekspertiza qilish masalasi maxsus tadqiq etilmagan.

Dissertatsiyani yozish jarayonida yuqorida ko‘rsatilgan ilmiy tadqiqotlar sinchiklab o‘rganildi, munosabat bildirildi va zarur o‘rinlarda foydalanildi.

Tadqiqot mavzusining dissertatsiya bajarilgan oliy ta’lim muassasasining ilmiy-tadqiqot ishlari rejalarini bilan bog‘liqligi. Tadqiqot Alisher Navoiy nomidagi Toshkent davlat o‘zbek tili va adabiyoti universiteti ilmiy tadqiqot ishlari rejasiga muvofiq “O‘zbek tili sistemaviy tadqiqi” yo‘nalishi doirasida bajarilgan.

Tadqiqotning maqsadi. Tilshunoslikning zamonaviy yo‘nalishlaridan biri sifatida lingvistik ekspertologiya mohiyatini asoslash va amaliyatga tatbiq etish, aynan o‘zbek yozma matnlarida lingvistik ekspertiza uchun zarur bo‘lgan tilshunoslik nazariyasi va lisoniy mexanizmlarini olib berishdan iborat.

Tadqiqotning vazifalari. Tadqiqotning vazifalari etib quyidagilar belgilandi:
lingvistik ekspertizaning yuzaga kelishi, shakllanishi haqidagi mavjud
nazariyalarni qiyosiy o‘rganish va tahlil qilish;

sud-huquq tizmida lingvistik bilimlar talab qilinadigan holatlarni tasniflash;
o‘zbek yozma matnlarining xarakterli xususiyatlarga muvofiq lingvistik
ekspertizaning tarkibiy qismlarini belgilash va tavsiflash;

lingvistik ekspertizaning tahlil bosqichlari masalasiga oydinlik kiritish, sud,
tergov va tergovgacha bo‘lgan jarayonda yuzaga keladigan har qanday ziddiyatli
matnlarga xos umumiyligi va muayyan holatlarga nisbatan xususiy tahlil bosqichlarini
ishlab chiqish;

lingvistik ekspertiza metodologiyasini asoslash, metodologik masalalarini
belgilash va ularga yechim topish;

ijtimoiy tarmoqlardagi yozishmalar misolida umumiyligi tahlil metodlarini to‘g‘ri
qo‘llash mezonlarini ishlab chiqish;

zamonaviy antroposentrik paradigma asosida shaxs kognitiv faoliyatini tadqiq
qilish;

shaxsni obro‘sizlantirish mazmunli birliklarni lingvistik ekspertiza qilishning
ilmiy-nazariy mexanizmlarini ishlab chiqish, haqorat bilan bog‘liq holatlarda
ekspertizaning yuridik va lingvistik tarkibiy qismlarini ajratish;

keng mohiyatga ega tushuncha sifatida lingvistik ekspertizada matn
avtorizatsiyasi masalasini izohlash;

kriminalistik xarakterga ega matn avtorizatsiyasi bilan bog‘liq holatlarni
lingvistik ekspertiza qilish.

Tadqiqotning obyekti sifatida turli konfliktli matnlar, guvoh, gumonlanuvchi,
aybdor ko‘rsatmalari, nutq hodisasini aks ettiruvchi kriminalistik matnlar, yuridik
hujjatlar va boshqa yozma matnlar xizmat qiladi.

Tadqiqotning predmeti sifatida o‘zbek tili yozma matnlarini lingvistik
ekspertizadan o‘tkazish jarayoni, bosqichlari, metodlari olindi.

Tadqiqotning usullari. Dissertatsiyada deduksiya, induksiya, kuzatish,
qiyoslash, analiz, sintez, eksperimental va lingvistik tahlil metodlaridan foydalanildi.
Shuningdek, lingvistik ekspertizaga taalluqli kontekstual va konseptual tahlil,
komponentlarni tahlil qilish, sifat va miqdoriy tahlil usullariga tayanildi.

Tadqiqotning ilmiy yangiligi quyidagilarda ko‘rinadi:

o‘zbek yozma matnlarida lingvistik ekspertizaning siyosiy nutqlar lingvistik
ekspertizasi, nomlanish bo‘yicha lingvistik ekspertiza, noverbal nutqiy vositalar
lingvistik ekspertizasi singari turlarini tahlil qilishning lingvistik, yuridik,
ekspertologik mezonlari mavjudligi dalillangan;

haqorat mazmunidagi konfliktli matnlarni lingvistik ekspertizadan o‘tkazish






1.2 - rasm. Lingvistik ekspertizaning umumiyligi tahlil bosqichlari.

Olingan ma’lumotlar asosida dastlabki ekspert xulosasi:

matnning leksik xususiyatlariga muvofiq (*millatchi* so‘zi ishlatilgan) muallif o‘zbek millatiga mansub emas;

matn muallifi oliy ma’lumotli shaxs emas. Asos: matndagi leksik xususiyatlarda direktorning past tabaqada qarashi haqida aytib o‘tiladi;

matnning leksik, sintaktik, morfologik xususiyatlariga muvofiq, matn muallifi xodimlardan emas, ota-onalardan. Ota-onalar mакtabning hisob-kitob mablag‘lari, budgeti haqida ma’lumot olish, uni tahlil qilish vakolatiga ega emas.

Demak, matn mакtab faoliyatiga bevosita taalluqli shaxs tomonidan yozilgan. Mакtabda qorovul yoki farrosh bo‘lib ishlovchi ota-onalardan yozilgan degan xulosa ham to‘g‘ri kelmaydi. Yuqorida qorovul, ombor mudiriga nisbatan ham jazo chorasi qo‘llanishi so‘ralgan. Mакtabda ota-onalardan tuzilgan kuzatuv kengashlari faoliyat yuritadi. Har bir sinfda ham ota-onalar kengashi raisi mavjud. Sinf ota-onalar kengashi raisi faqat o‘zi raislik qilayotgan sinf haqidagi ma’lumotlar bilan ish ko‘rishi hisobga olinadigan bo‘lsa, muallif mакtab kuzatuv kengashi vakili.

Yakuniy xulosa: muallif o‘rta ma’lumotli, boshqa millatga mansub, mакtab kuzatuv kengashi a’zolaridan biri bo‘lishi mumkin.

Demak, tahlilni tog‘ri tashkil qilish to‘g‘ri xulosa chiqarishga omil bo‘ladi.

Lingvistik ekspertologiya metodologiyasi nazariya va amaliyotni tashkil qilish, qurish prinsiplari, usullari, metodlari va vositalari tizimidir.

Metodikasi – bilish usuli, belgilangan maqsadga erishish uchun o‘rganilayotgan voqea, ob’ekt, hodisaga yondashish.

Lingvistik ekspertizaning metodologik masalalari ekspertizani nomlash, ob’ektlarini belgilab olish, lingvist-ekspertlar tayyorlash va malakasini oshirish, xususiy lingvistik ekspertiza markazlarini tashkil etish bilan bog‘liq holatlarda ko‘rinadi. Lingvistik ekspertizani tashkil etishda umumiy va xususiy metodlar ajratiladi. Umumiy metodlar ekspertiza o‘tkazishning dastlabki bosqichida amal qiladi. Xususiy metodlar esa matn mohiyatini to‘la tushunish, tahlil qilish imkoniyatini yuzaga keltiradi.

III bob “Ziddiyatli holatlarda lingvistik ekspertiza o‘tkazish jarayoni “ deb nomlanib, haqorat mazmunli matnlarda lingvistik ekspertiza va lingvistik ekspertologiyada matn avtorizatsiyasi masalasiga bag‘ishlanadi. Bobda turli konfliktli matnlarda lingvistik ekspertiza o‘tkazish jarayoni tajribalar asosida keltirilgan. Ekspert xulosalari shakllantirilgan. Xusan, “Haqorat mazmunli matnlar bo‘yicha lingvistik ekspertiza o‘tkazish jarayoni” deb nomlangan bo‘limda shaxsni obro‘sizlantirish mazmunidagi matnlar tasnifi, ekspert xulosalarini shakllantirish asoslari keltirilgan. Haqorat mazmunli matnlarda yuridik va lingvistik jihatlar quyidagicha farqlangan: 1) Yuridik norma talabiga rioya qilish (lingvistik ekspertiza yuridik malakani o‘z ichiga olmaydi); 2) tilning ko‘p funksionalligini hisobga olish, masalan, salbiylik va maqsadli yo‘nalganlik ottenkasidan xoli oddiy nutq akti ham informatsiyani qabul qiluvchining psixologik holatiga ko‘ra haqorat, tahqir, kamsitish tariqasida qabul qilinishi mumkin; 3) ekspertiza og‘zaki buzg‘unchilik strategiyasini misollar bilan ko‘rsatishi kerak. 





2006-yil 16-fevral kuni o‘t o‘chirish xizmatiga favqulodda qo‘ng‘iroq bo‘ladi. O‘t o‘chiruvchilar kelganda erkak bolani qutqarib qolganini, biroq xotini yotoqda qolganligini aytadi. O‘t o‘chiruvchilar hayotini xavf ostiga qo‘yib, deyarli kuyib bo‘lgan ayolni yotoqdan olib chiqishadi.

Ayol sud ekspertizasiga yuborilganda, quyidagi xulosalar kelib chiqadi:

1. Ayol tungi kiyimda emas, kunduzgi libosida bo‘lgan;
2. Ayol tanasidagi jarohatlar kuyish natijasi emas;
3. Toksikologiya hisobotlariga muvofiq, ayol o‘pkasida yong‘indan chiqqan zaharli gaz aniqlanmadı.

Ushbu dastlabki ekspertiza ayol yotganida nafas olmaganligi haqida xulosa beradi. Ayrim guvohlar ayolning kunning ko‘p qismini uyida o‘tkazishi to‘g‘risida guvohlik beradi. Ayol tomonidan eriga, qarindoshlariga va boshqa bir qator hamkasblariga SMS xabarnomalar yuboriladi. Ayolning eri tomonidan yozilgan SMSlar tahlil qilinganda, ayolga taalluqli bo‘lmagan, ko‘pchilikda qo‘llanmaydigan o‘ziga xos yozuv uslubi mavjud. Ayolning qo‘l telefonidan qotillik sodir bo‘lgan kuni yuborilgan xabarlar eri tomonidan oldin yozilgan turli SMS xabarlar uslubiga mos keladi.

Tahlil davomida sud uchun ashyoviy dalil sifatida olingan SMSyozishmalar sinchiklab ko‘zdan kechirilganda, qotillik sodir bo‘lgan kuni ayolning qo‘l telefonidan yozilgan SMSlarining oldin yozgan SMS yozish uslubiga mos keladi. Sud-tergov surishtiruv natijalariga ko‘ra er(N) jinoyatni qasddan uyunshirgan, u xotini nomidan xat yozib, go‘yo o‘z joniga qasd qilmoqchi, uyni yoqib yubormoqchiday taassurot qoldirishi uchun SMSdan ham foydalanadi. Sud-tergov jarayonida gumonlanuvchi tergov qilinadi, telefonda gaplashgan xabarları yozib olinadi, jinoyat joyida aniqlangan izlar tahlil qilinadi, sud-tibbiyot ekspertizasi xulosalari asosida N qotil sifatida aybdor deb topiladi va jazoga hukm etiladi.

XULOSA

1. Lingvistik ekspertiza sud ekspertizalarining bir turi bo‘lib, tilshunoslikning yangi yo‘nalishlaridan biri sifatida lingvistik ekspertologiya sifatida nomlanishi joiz. Lingvistik ekspertologiya sud jarayoni bilan bevosita bog‘liq holda, konfliktli holatlarga yechim topishga, dalillarni asoslashga xizmat qiladigan soha. Ushbu soha rivoji ham tilshunoslik, ham yurisprudensiya uchun birday ahamiyat kasb etadi.





Introduction (the abstract of the (PhD) dissertation)

Topicality and necessity of the thesis. In World linguistics, in the following years, integration of science has been a factor of interaction in science sectors, cooperation in the solution of problems and issues. As a result of the development of science, linguistics, along with other fields, began to be viewed from a new perspective. This, in turn, paved the way for the emergence of modern linguistics. Now several areas of modern linguistics have formed and reached the stage of development. The practical function of language began to work extensively in various branches of science. The above factors led to the creation of several studies¹.

The interrelation of language and law in world linguistics, the need to study legal materials from a linguistic point of view has led to the formation of a new direction - linguistic expertise. Linguistic expertise can be called one of the new directions of practical linguistics. Presently, there is a need for the participation of linguists in the process of judicial proceedings of various types. Because, the study of conflicting texts, the analysis of the accused, suspected speeches from the point of view of the linguistic point of view, will help the case to be considered objective way.

Conducting linguistic expertise requires in-depth knowledge from a specialist. In conducting linguistic expertise requires in-depth knowledge from a specialist. In court cases, there will be certain contradictory cases, in which, in addition to lawyers, there will be a need for the cooperation of psychologists, politicians, and linguists. In this cooperation, a new field of linguistics – linguistic expertise-is emerging. In Russian linguistics, several studies have been created on the forms and bases of its implementation in linguistic expertise. However, Uzbek written texts are different from other texts in language according to their language and ethnic characteristics. The relevance of the study is that the language is equally valid in other branches of science and its importance is also high. In this sense, it is necessary to understand the role and possibility of linguistics as a factor of development in science networks. It is necessary to understand, interpret and substantiate linguistic expertise, which is considered to be one aspect of Applied Linguistics, which arose as a result of this need. The application of existing linguistic theories in linguistic expertise and their role and function in the identification and coverage of evidence is especially relevant. In written texts, the assessment and analysis of situations of varying degrees (such as insult, defamation, plagiarism, anonymity, corruption) help to draw a general objective conclusion. And this means that there is a need to directly determine linguistic expertise. As a result of modern linguistics, various theories are put forward and based. In our opinion, it is necessary to apply existing theoretical ideas to practice and determine their effectiveness aspects. Also, the issue of applying existing ideas on linguistic expertise to practice and determining their role in the transfer of texts from linguistic expertise is actual. This issue is not only for jurist linguistics but also to a certain extent relevant to all modern linguistics. The role of linguistics is important in improving judicial performance, preventing violations and crimes, proving existing cases based on language evidence, assessing whether the evidence. In this sense, the need to organize, evaluate forensic experts, prevent aggression against property, improve the activities of linguistic expertise centers and train experts in this regard increasingly determine the relevance of the study.

Relevance of the research to the priority areas of science and developing technology of the Republic. Development of the Republican Science and technology of the dissertation "The formation and implementation of a system of innovative ideas in the social, legal, economic, cultural, spiritual and educational development of an informed society and a Democratic state" was carried out by the priority direction.

Problem development status. It is difficult to substantiate with concrete evidence when linguistic expertise came into being. Every term that enters science has its history, stage of formation, and period of development. We can not say that linguistic expertise has also come into being and formed in a certain period. Generalization of various attributes of words and sentences used in speech, in particular length, timbre, etc., allows diagnosing the psycho-psychological state of the author of the speech. In the XIX century, mathematical scientists argue that speech attributes should be generalized. More precisely, they say that it is necessary to measure the length of the word, the length of the sentence, and check the construction form of the sentence. The emergence of new forms of industrial, economic, socio-political relations has encouraged the study to deal with the specific problems of science. These problems, as a rule, arose in connection with the philological provision of professional legal activity in various forms (creativity of law, law enforcement, judicial notary, forensic expert). In World linguistics and jurisprudence, several studies on this subject have emerged. Particularly, M. V. Ablin⁴⁰, A. N. Baranov⁴¹, Yu. A. Belchikov⁴², E. N. Bondarenko⁴³, K. I. Brinev⁴⁴, M. Coulthard⁴⁵, N. D. Golev⁴⁶, Y. I. Galyashina⁴⁷, Tim

In Uzbek linguistics, the application of language in various fields, its implementation is directly related to the court. Sh. Iskandarova⁵², M. Mirhamidov, S. Hasanov¹⁵, Sh. Shahobiddinova¹⁶, Sh. Shahobiddinova and the team of authors, Q. Muydinov¹⁵ research were carried out.

Relevance of the dissertation research with the plans of the scientific research works of higher educational or scientific research institutions where the dissertation has been conducted. The research was conducted by the research plan of the Tashkent State University of Uzbek Language and Literature named after Alisher Navoi in the direction of "Systematic study of the Uzbek language".

The purpose of the study is to substantiate the essence of linguistic expertise and its application to practice, to clarify the solution of identified problems. Also, the theory of linguistics on which linguistic expertise is based is the disclosure of linguistic mechanisms.

Tasks of research. The objectives of the research work were defined as:

coverage of the study of linguistic expertise as a problem in world linguistics and jurisprudence;

analysis and generalization of theoretical ideas on the occurrence of linguistic exaggeration;

description and analysis of components of linguistic expertise;

substantiation of methodological issues of linguistic expertise;

defining the main aspects of linguistic expertise in Uzbek texts and identifying the stages of linguistic expertise;

classification and implementation of methods of linguistic examination in Uzbek written texts;

linguistically modern knowledge based on the theoretical assumption that applies in the appointment of the examination of the effectiveness of the identification and analysis;

The results of research facilities as legal documents, specifically problematic texts, the court examination directly related to the speech event, reflecting the text; speech event of being a witness a repeat of the guidelines, the protocol serves other written and oral speech, written text.

The results of the research subject as of the examination process text written in English linguistically, this stage and methods were taken.

The results of the research methods. Deductive issues in the implementation of research in inductive analysis (comparison) and the methods of synthesis, as well as court-text examination based on analysis of linguistically her controversial examination of the text in the synthesis of conducting this type of research, has formed linguistically. Vocabulary and semantic analysis, content analysis, quantitative analysis methods to linguistically.

The scientific novelty of research:

the existing problem situation in the linguistic examination of written texts of the Uzbek language the theoretical methodological foundations of the examination in accordance with linguistic features are created when restoring the copyright, determining the state of plagiarism, giving a conclusion on advertising and insult meaningful texts;

in Uzbek written texts, it is proved that there are linguistic, legal, expert criteria for analysing such types of linguistic examination as linguistic examination of political speeches, linguistic examination of naming, linguistic examination of non-verbal speech means;

in the process of linguistic examination of conflict texts in the content of insults in the case where linguistic and expert qualifications are relied upon, which the linguist-expert should substantiate extra-linguistic (legal) aspects are differentiated and their integrity is proven;

controversial situations associated with the identification of the author of the text: the author of handwritten texts, the author of a particular intellectual property artistic, scientific, journalistic work, the author of anonymous and suicide-related letters are based on the fact that they have a substantive generality

Practical and theoretical significance of the study. The theoretical significance of the study lies in the fact that it contributes to increasing the role of existing theories in linguistics in practice. Promotes the development of linguistic expertise in Uzbek linguistics and jurisprudence. The formulation of linguistic expertise in various problematic texts (both oral and written) also helps to summarize expert decisions. The results of the study can be directly applied in conducting forensic linguistic examinations and in cases of various categories (insults, threats, calls for extremist activity, etc.).) can serve as a basis for methodological developments and recommendations on the organization of forensic linguistic examinations within. It serves as the basis for research on the linguistic expertise of advertising, billboards, various economic texts that will be created later.

Reliability of the research results obtained relies on the theoretical aspects of scientific research at the international level and the republic of the case, the court of justice under the ministry of Justice named Kh. Sulaymonova, expert-staff of forensic expertise under the Ministry of internal affairs, Andrea Nini, a professor at the University of Manchester and professor at Aston University, Chief-mayor Tim's big experience and recommendations. Published scientific articles and abstracts are introduced into practice. It was carried out by the decision of the president of the Republic of Uzbekistan "On further improvement of judicial expert activity" PD-4125 in January of 2019.

Implementation of the research results. Based on the scientific results achieved on the territorial characteristic of non-literary elements in personal correspondence in the Uzbek language: linguistic and extra-linguistic factors application of research results related to the process of linguistic expertise of texts in Uzbek among fraternal Turkic languages to the scientific and educational process among linguistic studies from the point of view of modern linguistics; introduction of terms on linguistic examination into science; methods for identifying non-literary lexical, grammatical

and phonetic elements in conflict texts; scientific justification and confirmation that linguistic expertise is one of the main tools in determining the author of problematic written texts; from the conclusions on the development of the theoretical and practical foundations for determining the criteria for determining the author of the anonymous correspondence, the FA-F1-G003 "Functional vocabulary in the current Karakalpak language", conducted by the Karakalpakstan branch of the Academy of Sciences of the Republic of Uzbekistan; FA-A1-G007 was used in fundamental and practical scientific projects on the topics "Karakalpak sayings and proverbs as a linguistic research object". (Certificate of the Department of Karakalpakstan of the Academy of Sciences of the Republic of Uzbekistan dated August 3, 2021 No. 17-01/122). As a result, the principles of classification of conflict texts as an object of linguistic research have been improved.

Scientific and theoretical views on the specifics of a person's speech were used to write the script for the talk show of the national television and radio company of Uzbekistan "Oydin hayot live" (National Television and Radio Company of Uzbekistan state institution "Uzbekistan" directory No.01-13-1594 dated October 8, 2021).

As a result, the essence of linguistic examination, the examination of various conflict texts, the basics, and the need for an examination of a person's speech are presented to the attention of a wide range of congregations. On October 18, 2021, the TV channel "Madaniyat va marifat" ("Culture and enlightenment") was used to compose a script for programs on the show "Bugunning gapi" ("The talk of today") (State institution of the National Television and Radio Company of Uzbekistan TV channel "Madaniyat va marifat" ("Culture and education") directory No.01-16/201, October 18, 2021). As a result, information on the essence, practical significance, tasks, and role of linguistic examination as a novelty in the system of Applied Linguistics and forensic law has been submitted.

From the analysis and conclusions regarding the implementation of personal identification of the author of the text in cases of anonymity, the number I-OT-2019-42 within the framework of the State scientific and technical programs for 2020-2021 were used in the innovative project called "Creation of an electronic poetic dictionary (human image, character, nature, and image of national symbols) of Uzbek and English languages" to illuminate the place and role of pragmatic factors in the speech realization of incomplete sentences (reference number 04/1-1998).

As a result, the terms related to the human character representing the identification of the person in cases related to the text authorization of the forensic examination and linguistic examination served to enrich the project.

From its conclusions on the analysis of texts subject to examination in the process of forensic examination as conflicting texts following their linguistic features, a book which was published in 2018 in the publishing house "Tafakkur bo'stoni", recommended by the Ministry of Higher and secondary special education as a textbook "The current Uzbek language" in paragraph 2 of the textbook, which is called "Language, linguistic, speech attitude" ("Til, lison, nutq munosabati") in an article entitled "Language violence or popular linguistic crimes" ("Tilga zo'rovonlik yoki mashhur lingvistik jinoyatlar") given for independent reading, in the statement of

conflict situations in paragraph 6, called "Linguistic conflict and its types" ("Lisoniy ziddiyat va uning turlari"), the conclusions of chapters 1 and 3 of the dissertation were used (2018.27.03. No. 274-312) reference No. 04/1-1972).

As a result, it served to identify the language conflict and clarify its essence.

Approbation of the results of the study. The results of the research were discussed at two International and three Republican scientific-practical conferences and seminars.

Publication of research results. A total of 12 scientific works have been published on the topic of the study. In particular, the main scientific results of the doctoral (Ph.D.) dissertations of the Higher Attestation Commission of the Republic of Uzbekistan were published in 9 scientific publications (5 of them in the Republic and 4 of them in a foreign Journal).

The outline of the thesis. The dissertation consists of an introduction, chapter 3, conclusion, list of used literature, and application. The size of the dissertation is 132 pages.

MAIN CONTENT OF RESEARCH STUDY

In the introductory part, the information on the priority directions of the development of science and technology of the Republic is based on the relevance of the topic, the objectives and objectives of the research, the subject, and the subject are described, compliance with the priority directions of the development of Science and Technology of the Republic is indicated, information about scientific novelty and practical results are given.

Chapter I highlights the issues of the essence, scope and boundaries of the concept of linguistic expertise, its components, stages of analysis. The historical roots, scope and limits, the essence of linguistic expertise are explained. The periods and trends of the industry development are studied in the world linguistic expert science. Features of linguistic expertise of Uzbek written texts. This section presents the work "Evans' statements" by Jan Svartvik, who first used the term "linguistic expert science", and also outlines the basics of linguistic expertise in Russian and English linguistic expert science.

Studies on sociolinguistic and pragmatic, pragmalinguistic features of written and oral speech have been created in Uzbek linguistics. This, in turn, will serve as a basis for determining and substantiating the specifics of conducting linguistic expertise of Uzbek written texts⁵³. Through linguistic expertise, the boundaries of the competence of a linguist expert are determined and the issues to be resolved are clarified.

In the section "Description of the components of linguistic expertise", the classification of conflicting types of text subject to linguistic expertise is carried out. The components identified by the opinions of linguistic experts are analyzed, and the necessity of identifying specific types of linguistic expertise in Uzbek written texts is justified. Linguistically separate the components of the examination to russian scientists Galyashina E.I., Rossinskaya E.R.²⁰, L.V. Azhnyuk²¹, I.K. Brinyev²² A.N.


in the final part, when conducting a linguistic examination, it is advisable for the linguistic examination of Uzbek written texts to include in the composition of the components according to the content:









The SMS correspondence obtained during the analysis as material evidence for the court, upon careful examination, corresponds to how the SMS correspondence recorded from the woman's wrist phone on the day of the murder was written by her earlier. Of course, for sentencing, for giving a conclusion, this will not serve as concrete evidence, but it will help to find the "tip of the tracing paper".

In this table some of the messages sent from the cell phone are analyzed. During the analysis, it becomes clear that some elements belong to F (female), and some elements belong to N (male). Paying attention to the sequence, the expression of emotion indicates that it is close to the female style of speech. However, according to the formal features of the text, the H-shaped characteristic leads to a greater extent. Based on the fact that allegedly N tried to use a simulated Fga record, it can be concluded that the SMS was written by N.

The forensic investigation found that the husband (N) committed the crime intentionally, he also uses SMS to create the impression that he is writing a letter to his wife, allegedly wants to commit suicide, set fire to the house. During the judicial investigation, the suspect is subjected to strict pressure, his messages said on the phone are recorded, traces found at the crime scene are analyzed, based on the conclusions of the forensic medical examination, he is found guilty of murder and sentenced to punishment.

CONCLUSION

1. Linguistic expertise is practiced as a type of forensic examination, as one of the new areas of linguistics, it is permissible to call linguistic expertise.

2. Linguistic expert science is a branch directly related to legal proceedings, serving to find solutions to conflict situations, substantiation of evidence. The development of this branch is equally important for both linguistics and jurisprudence.

3. In linguistic expertise, the object under study (text in various forms) does not always have a forensic character. It is advisable to assign linguistic expertise to socially and politically dangerous, dubious situations (various political speeches, advertising, names).

4. Linguistic expertise of Uzbek written texts is ethnic in nature. Therefore, based on world experience, it is necessary to create a holistic model of linguistic expertise of Uzbek written texts. This model operates in each of the types of linguistic expertise and coordinates the activities of linguistic experts.

5. Given that Uzbekistan is a multinational country, changes in language and speech acts are also quite confusing. In the linguistic examination of monolingual and multilingual texts, it is necessary to distinguish between general and particular features.

6. It is not yet possible to establish a single boundary in determining the components of linguistic expertise. Given that the exchange of information is accelerating and acquiring various manifestations, there is a high probability of expanding the range of conflict situations related to speech forms. After the development of the general analytical stage of the linguistic examination of Uzbek written texts, this analysis will serve as the basis for further linguistic examinations.

7. Linguistic expertise, along with other forensic examinations, is a process that helps to draw objective conclusions. In this regard, it is necessary to develop mechanisms for training and advanced training of linguists-experts in the republic, to improve the activities of existing linguistic expertise centers.

8. Taking into account the large number of specific types of conflict subtypes and in most cases, the occurrence of disputes, conflicts during court proceedings, when

determining the components of linguistic expertise, non-verbal speech means, nimirings, political speech linguistic expertise create prerequisites for further improvement of the reform of the state language, the possibility of positive resolution of various conflict situations.

9. Linguistic expertise of political speeches differs from forensic political expertise. If a forensic political science examination is carried out under circumstances that pose an increased social and political danger in the form of encroachments on the constitutional system, the President, the national identity of the Republic of Uzbekistan, then the linguistic examination of political speeches are aimed at substantiating the true essence of the speeches of various statesmen, officials who caused widespread discussion among the masses.

10. Linguistic expertise of non-verbal means of speech is used to decipher the "code" of various gestures used in the process of speech, or instructions, by representatives of various criminal groups and extremist groups;

11. Linguistic examination of goods (of various names: cafes, restaurants, state and non-state organizations) serves to identify and eliminate such circumstances as the fact that the chosen name corresponds / or does not correspond to the norms of the state language, is subordinate / or is not subordinate to a certain idea, does not affect/does not affect the copyrights of well-known world brands.



ВВЕДЕНИЕ (автореферат диссертации)

Целью исследования является-обосновать сущность лингвистической экспертизы и применить ее на практике, уточнить вопрос о решении выявленных проблем. Также лингвистическая теория, на которую опирается лингвистическая экспертиза, заключается в раскрытии языковых механизмов.

Объектом исследования служат юридические документы, специальные проблемные тексты, тексты, непосредственно отражающие речевой феномен, относящийся к криминалистике; показания свидетелей, в которых речевой феномен воспроизводится, протоколы и другие письменные тексты, в которых записывается устная речь.

Научная новизна исследования:

созданы теоретико-методологические основы экспертизы в соответствии с лингвистическими особенностями при даче заключения о рекламе и оскорблении значимых текстов, а также при восстановлении авторских прав, определении состояния plagiarismа;

доказано, что в узбекских письменных текстах существуют лингвистические, юридические, экспертные критерии для анализа таких видов лингвистической экспертизы, как лингвистическая экспертиза политических выступлений, лингвистическая экспертиза именования, лингвистическая экспертиза неверbalных речевых средств;

в процессе лингвистической экспертизы конфликтных текстов по содержанию оскорблений в случае, когда полагаются лингвистические и экспертные квалификации, которые лингвист-эксперт должен обосновать, дифференцируются экстралингвистические (юридические) аспекты и доказывается их целостность;

спорные ситуаціи, связанные с идентификацией автора текста: автор рукописных текстов, автор определенной интеллектуальной собственности, художественного, научного, журналистского произведения, автор анонимных и связанных с самоубийством писем основаны на том факте, что они имеют содержательную общность.

Внедрение результатов исследований. На основе научных результатов, достигнутых по территориальной характеристике нелитературных элементов в личной переписке на узбекском языке:

лингвистические и экстралингвистические факторы применение результатов исследований, связанных с процессом лингвистической экспертизы текстов на узбекском языке среди братских тюркских языков, к научно-образовательному процессу среди лингвистических исследований с точки зрения современной лингвистики;

введение в науку терминов лингвистической экспертизы;

методы определения нелитературных лексических, грамматических и фонетических элементов в конфликтных текстах;

научное обоснование и подтверждение лингвистической экспертизы как одним из основных инструментов определения автора проблемных письменных текстов;

из выводов о разработке теоретических и практических основ выявления критериев определения автора проблемных письменных текстов, анонимная переписка, FA-F1-G003 “Функциональная лексика в современном каракалпакском языке”, проведенная Каракалпакстанским филиалом Академии наук Республики Узбекистан;

FA-A1-G007 использовался в фундаментальных и практических научных проектах по темам “Каракалпакские поговорки и пословицы как объект лингвистического исследования”(Справка Отделения Каракалпакстана Академии наук Республики Узбекистан от 3 августа 2021 года № 17-01/122).

В итоге были улучшены принципы классификации проблемных текстов как объекта лингвистического исследования.

Научно-теоретические взгляды на специфику речи человека были использованы при написании сценария ток-шоу hatsіональной телерадиокомпании Узбекистана “Ойдин хайот live” (Hatsіональная телерадиокомпания Узбекистана государственное учреждение "Узбекистан" справочник №01-13-1594 датированный 8 октября, 2021).

В результате суть лингвистической экспертизы, изучение различных конфликтных текстов, основы и необходимость экспертизы речи человека представлены вниманию широкого круга прихожан. 18 октября 2021 года телеканал "Маданият ва марифат" ("Культура и просвещение") был использован для составления сценария программ на шоу "Бугуннинг гапи" ("Разговоры сегодняшнего дня") (Государственное учреждение Hatsіональной телерадиокомпании Узбекистана телеканал "Маданият ва марифат" ("Культура и образование") справочник №01-16/201, датированная 18 октября 2021 года). В результате была представлена информация о сущности, практическом значении, задачах и роли лингвистической экспертизы как новшества в системе прикладной лингвистики и судебного права. Из анализа и выводов, касающихся реализации персональной идентификации автора текста в случаях анонимности, номер I-OT-2019-42 в рамках Государственных научно-технических программ на 2020-2021 годы был использован в инновационном проекте под названием "Создание электронного поэтического словаря (образ человека, характер, природа и изображение hatsіональных символов) узбекского и английского языков", чтобы осветить место и роль pragmatischen faktorov в речевой реализации неполных предложений (ссылка № 04/1-1998).

Для обогащению проекта послужили термины, связанные с человеческим характером, представляющие идентификацию человека в случаях, связанных с текстовым разрешением судебной экспертизы и лингвистической экспертизы. Из его выводов по анализу текстов, подлежащих экспертизе в процессе судебной экспертизы, как противоречивых текстов с учетом их лингвистических особенностей, книга, которая была опубликована в 2018 году в издательстве "Тафаккур бостони", рекомендована Министерством высшего и среднего специального образования в качестве учебника “Современный узбекский язык” в параграфе 2, который называется "Язык, лингвистическое, речевое отношение" ("Тил, лисон ва нутқ муносабати") в статье под названием “Языковое насилие или популярные лингвистические преступления” ("Тилга зўровонлик ёки

машхур лингвистик жиноятлар”), предоставленной для самостоятельного прочтения, в изложении конфликтных ситуацій в параграфе 6 под названием “Лингвистический конфликт и его типы” (“Лисоний зиддият ва унинг турлари”), были использованы выводы глав 1 и 3 диссертации (2018.27.03. № 274-312) ссылка № 04/1-1972). В результате чего было выявлено языковые конфликты и прояснение его сути.

Краткое содержание диссертации. Диссертация состоит из введения, 3 глав, заключения, списка использованной литературы и приложения. Объем диссертации составляет 132 страниц.
